

NGI WEBSITE TERMS OF USE (2026 EDITION)

Effective Date: May 17, 2026

Welcome to the website of **Nadalini Global, Inc. (“NGI”)**. By accessing or using this website, you agree to comply with and be bound by the following Terms of Use. Please read them carefully. If you do not agree to these terms, you should not use this website or our digital intake forms.

1. ACCEPTANCE OF TERMS

These Terms of Use govern your access to and use of the NGI website, including any content, functionality, and services offered on or through the site. By using the site, you represent that you are of legal age to form a binding contract and meet all eligibility requirements.

2. BROKER DISCLOSURE (MAP-21) — BROKER VS. CARRIER

Nadalini Global, Inc. (“NGI”) operates as an independent **property broker** under **MC-1469182** and **USDOT-3949236**.

- **Broker Status (MAP-21):** NGI is a broker/arranger of transportation and does **not** provide motor carrier transportation. Nothing on this website should be read as NGI holding itself out as a motor carrier.
- **Non-Carrier Status:** NGI does not own, operate, or maintain trucks or transportation equipment.
- **Third-Party Carriers:** All transportation is performed by independent, third-party motor carriers and other transportation providers. NGI’s role is limited to arranging transportation with qualified providers.

3. PROPRIETARY RIGHTS (OUR BRAND + OUR “SECRET SAUCE”)

The website and its entire contents (including but not limited to text, graphics, logos, trademarks, trade dress, forms, checklists, training materials, workflows, and any internal methods or know-how) are owned by **Nadalini Global, Inc.** and are protected by intellectual property and other laws.

- **NGI Brand Assets:** NGI’s name, logo, and related branding are NGI property. Don’t use them without our written permission.
- **Our “Secret Sauce”:** Any NGI processes, playbooks, templates, onboarding materials, pricing logic, routing methods, vetting criteria, and similar operational know-how—whether labeled confidential or not—are proprietary to NGI (the “Secret Sauce”). You don’t get any rights to it just because you visited the site.
- **Limited Permission (Public Downloads Only):** You may view and download documents specifically marked for public use (for example, W-9, MC Authority, Insurance COI) **only** for legitimate business verification and due-diligence purposes.

- **No Copying / No Sharing:** Unless NGI says “public download,” you may not copy, reproduce, modify, distribute, sell, publish, transmit, display, create derivative works from, or commercially exploit any site content or NGI materials without NGI’s prior written consent.
